Did your Agency Contribute to this Problem?

Failure to competitively bid up fit equipment, vehicles, installation labor in public procurement has created a limited or artificial market of suppliers & up fitters resulting in artificially high(er) prices for Connecticut State,

City/Town public safety customers.

Following the State Lead

Since November 2012 the State of Connecticut has been renewing their contract with MHQ, accepting the same discount structure and while presumably evaluating new or refreshed products resulting in no opportunities for open competition.

Municipalities Favor, in overwhelming percentages, mimicking the Upfitter and Brands found on the State Contract 12PSX0194.



Example: Connecticut State Police

The Connecticut State Police have a contractual relationship (12PSX0194) with MHQ, a well known Massachusetts based company with a Middletown, CT Operating unit performing vehicle aftermarket sales & vehicle upfit.



Example: Connecticut State Police

EQUIPMENT:

- ➤ Three brands account for 81% of the vehicle equipment upfit costs.
- CSP selected brands are offered at substantial discounts in States where multi-brand contractual approach is used.
- Except Massachusetts, the other New England States appear to not seriously solicit contracts for any brands outside what their agency specifically utilize.

BID Methodology – Percentage Off Mfg. "List" By State

State contracts for commodities such as Warning lights, Sirens and associated upfit gear are presented commonly as a percentage off manufacturers "list" price. In order to properly calculate a difference in price to the customer, the list must be calculated and the State contract discount taken.

The primary Add-On Vehicle Equipment Costs the CSP \$7,481.29 per car:

\$1,777.74 PER CAR (Potential Savings)

➤ Lights and Siren: (List Price: \$8,845) 58% Of Cost

Radio Equipment Console (List \$1,835)14% of Cost

Rear Partition and Security Storage: (List \$988)9% of Cost



MASS State Police v. CONN State Police

Vehicle Equipment + Labor Upfit Comparison



- > Same Vendor in Mass as Conn.
- ➤ Mass State Police are opaque with regard to a detailed price analysis.
- ➤ Individual Equipment is not identified by line item.
- Discounts from Manufacturers (vendors) retail pricelist are not disclosed.
- ➤ Labor for the upfit (Same for all of Mass) is not disclosed.
- ➢ Police Interceptor Utility, Marked unit has a single line item price of \$8,720 described for a Fully Marked PIU to include Whelen Core Lighting Package (SAME product family the CSP utilizes)



- Conn State Police are completely transparent with the costs, discounts and labor associated with their vehicle build.
- ➤ Labor Upfit Cost: \$2,250
- ➤ Total Vehicle Equipment: \$9,118.86
- ➤ Total Vehicle Equipment and Labor: \$11,368.86

MSP costs are \$2,648.86 (23%) less than CSP

Lights and Siren - Florida Sheriff Contract

FSA20-VEH18.0 FSA20-VEL28.0 Emergency Lights and Sirens Price Sheet

- ➤ PREMIUM LIGHTBAR PACKAGE WPLB LED 1 TIER, \$ 2,131.64, (\$65/Hour Install Labor)
- ➤ Whelen Premium All LED LFL Liberty Lightbar (Model S8FSA1), Fully loaded, 100% Solid State Electronics, manufactured in America with 15 Led Modules, Two Wire Controlled Traffic Advisor, (2) LED Flashing/Takedown Lights, (2) LED Flashing/Alley Lights, Mounting Kit, 295SLSA6 Combination Light/Siren Controller, SA315P Siren Speaker and Mounting Bracket.
- > Described as a *Premium Package, this price offer is 40% lower than CSP Contract.
- ➤ The MFG "constructs" a regional model numbers that are unique to Florida Sheriff where price comparisons are made difficult while in reality using the same products sold elsewhere.

Lights and Siren – State of New Hampshire Contract 8000178 WHELEN EMERGENCY VEHICLE LIGHTING & SIRENS

- ➤ 46% off Whelen MSRP for Direct Orders to Whelen Engineering on all Parts and Accessories
- From January 2020 Until July 2021 The State of New Hampshire has issued payments to Whelen Engineering totaling \$285,816 (List Price of \$529,288)
- ➤ In Connecticut, the same product would have cost: \$317,572 or \$31,756 More than in New Hampshire.

New Hampshire State Police v. CONN State Police

Vehicle Equipment + Labor Upfit Comparison



- ➤ Vendor is the same for both agencies
- ➤ New Hampshire State Police utilize both Sedans and SUVs.
- ➤ Single Partition and Push bumper (labeled options in NH Contract) included in pricing comparison. LowPro (no roof bar) Sedan Labor: \$2,046
- ➤ LowProfile (no roof bar) Vehicle Equipment: \$8,422.45
- ➤ LowProfile Total: \$10,468.45
- ➤ HighProfile w/Light Bar Labor: \$1,560
- ➤ HighProfile w/Light Bar Equipment: \$8,630.75
- ➤ Total HighProfile: \$10,190.75

- ➤ Conn State Police contract allows complete transparency with the costs, discounts and labor associated with their vehicle build. 'Patrol Car' Costs are used in comparison.
- > CT uses Push bumpers and Rear-Compartment partition
- ➤ Labor Upfit Cost: \$2,250
- ➤ Total Vehicle Equipment: \$9,118.86
- ➤ Total Vehicle Equipment and Labor: \$11,368.86

NHSP costs are 8% - 11% less than CSP

Lights and Siren – State of Maryland Contract

- ➤ 50% off Whelen Engineering MSRP Police Vehicle Equipment & Emergency Vehicle Warning Systems & Lighting as sold through Distribution. CONTRACT IS FOR FOUR (4) YEARS WITH TWO (2) ONE (1) YEAR RENEWAL OPTION. CONTRACT PERIOD 11/01/2017 TO 10/31/2023
- ➤ In Connecticut, 100 Cars worth of Whelen Eng Lighting/Sirens CSP Contract is \$530,800, the list price of this equipment is \$884,500.
- ➤ IN Maryland, 100 Cars worth of the same Whelen Engineering Lighting/Sirens would be \$ 441,365 -\$89,434 in Savings.

Lights and Siren – State of New York Contract

BID 19059 VEHICLE STANDARD AND EMERGENCY LIGHTING

- > 55.8% off Whelen Engineering Automotive List Price. Whelen Products During the Period: March 13, 2020 to December 31, 2024.
- ➤ In Connecticut, 100 Cars worth of Whelen Eng Lighting/Sirens CSP contract is \$530,800 the list price of this equipment is \$884,500.
- ➤ IN New York, 100 Cars worth of the same Whelen Engineering Lighting/Sirens for the CSP would be \$ 390,949, a savings of-\$139,851 and 15.8% Less in NY for new equipment.
- ➤ ** NY State Police purchasing a "Special" Bar and Siren package at \$1940 ea on this contract. A Similar Package in Connecticut City of the same product family Costing: 40% off List is \$2,173.20 for the Bar & \$1,109.40 for the Siren:

A Total \$3,286,60 OR \$1346 HIGHER in CONNECTICUT THAN in NEW YORK

Lights and Siren – State of Virginia Contract

E194-89772 WHELEN EMERGENCY VEHICLE LIGHTING & SIRENS

- ➤ 56.1% off Whelen Engineering Automotive List Price. 70% off Whelen Engineering Automotive Parts Pricelist. 70% off CANTROL WC (Used in many Conn towns) System Pricelist. Whelen Products During the Period: May 26, 2021 to May 25, 2024.
- ➤ In Connecticut, 100 Cars worth of Whelen Eng Lighting/Sirens CSP contract is \$530,800 the list price of this equipment is \$884,500.
- > IN Virginia, 100 Cars worth of the same Whelen Engineering Lighting/Sirens for the CSP would be \$ 388,295 or \$142,505 in savings, 16.1% Less for new equipment


- ➤ Emergency Lighting and light/siren controller. \$3,721.55
- ➤ Center console for radios/dock/controllers: \$673.15
- ➤ Rear Cargo divider/Partition and secure lockable rear cargo radio cabinet: \$1,007.97
- ➤ TOTAL: \$5,402.57 (comparable equip. to CSP) Same Brand
- ➤ SOURCE: VSP Fleet Replacement Schedule FY2022, October 2021



➤ Conn State Police Total Equipment: \$7,481.29 (comparable equip) to VSP & Same Brand

VSP Equipment costs are \$2,078.72 less than CSP

Vehicle Lighting/Siren Discounts – Northeast USA



DID YOU KNOW?

- ➤ A legal emergency vehicle requires far less lighting than is found in most departments. Many fleet managers have *self-determined* more lights is "safer". A large Connecticut Municipality pays under \$3,000 for a roof mounted bar & Siren/Speaker controller. This combination as with the Michigan cruiser are just as safe as \$5,000 paid by your town/city.
- Ford assembles an Explorer in under 20 hours of labor.
- ➤ Your towns cruiser takes closer to 40+ hours of labor to up fit, each accessory can add to that time.
- ➤ The GSA marked cruiser upfit cost \$3500/veh
